The above list contains the subscribers to the fund being raised in Billings with which to purchase seed and feed for needy and deserving farmers of Yellowstone county, but who have not established a bank credit and who only through some such aid can bring about that increased average of food crops which will stand between this section and starvation this winter.

The subscriptions were announced at a luncheon at the Northern hotel yesterday under the auspices of the Yellowstone county council of defense, appointed by Governor E. W. Stewart. Perhaps the plan of the council and manner of collecting subscriptions will bear mention. It is not a charitable proposition. Every farmer given assistance will be required to sign a note secured by a crop lien for the amount of the advance furnished. Consequently, if he a reasonable interest that a major portion of the loans made farmers. If signed not the entire amount will be refunded by the recipients this fall. It is only in case for this deficit that the guarantee subscriptions are sought. The total loss will be divided proportionately among the subscribers in the so-called transfer or guarantee note which they sign. It is estimated that this loss under no circumstances will exceed 50 percent, so that if a person subscribes for \$100, his loss would be only \$50. Again, it is required to make no cash advance through at this time; in fact, no demand will be made until after the loss has been determined this fall. Thus, in essence, a subscriber is simply advancing his credit to assist those who otherwise cannot put in an added acreage this spring.

The council is anxious to secure additional subscriptions to the list. It has collected a carload of wheat, one of oats and two of potatoes, and delivery of these will begin soon. The wheat and potatoes are not available, but the sale must come from Washington.

Today members of the council will make a survey of the business section, seeking additional subscribers. The need for more credit is imperative if Yellowstone county is to avoid itself of the opportunity now presented. Be ready for them, with a promise for a sum commensurate with your financial condition. It is a duty you owe your country, yourself and humanity.

The council is also desirous of securing options on any and all kinds of grain and forage, and anyone having these or knowing of their existence will confer a favor by communicating with it at the Chamber of Commerce building, Billings. It is realized that a great deal will have to be imported to meet the demand, but there are trucking lines which could be served in splendid advantage if the seed and feed could be secured more readily.
